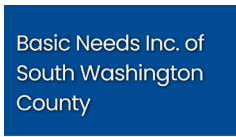

St. Paul Park Heritage Days Festival Parade Waiver and Agreement

I/we as representatives and members of the undersigned unit/organization, have agreed for our benefit to participate in the St. Paul Park Heritage Days Festival Parade. By doing so, I/we agree to the following requirements:

I/we understand that inherent in our participation is the risk of serious personal injury and property damage. I/we understand that Basic Needs, Inc. of South Washington County, the City of St. Paul Park, the St. Paul Park Heritage Days Festival, Parade Director(s) and other staff, volunteers and members, will not provide us with protection against such injury and damage, and I/we assume all risk of such injury and damage to myself and all others under my direction and control, to my property and all other property under my direction and control.

I/we hereby waive and release any claim we have and may have in the future against Basic Needs, Inc. of South Washington County, the City of St. Paul Park, the St. Paul Park Heritage Days Festival, Parade Director(s) and other staff, volunteers and members, for any personal injury, property damage or other damage that I/we may sustain, whether or not caused in whole or in part by the negligence of such members which occurs during or as a result of our participation of the Heritage Days Parade.

I/we agree that myself or anyone operating a vehicle in the St. Paul Park Heritage Days Festival Parade or in conjunction with the event, have a valid driver's license to drive such a vehicle and is accompanied by the appropriate vehicle and liability insurance.

I/we agree there will be no use of alcohol, fireworks, explosives or any other items that may be considered illegal, dangerous, or inappropriate for a public event. I/we agree the St. Paul Park Heritage Days Festival Parade Director and his/her representatives are the final authority in decisions of appropriateness and we agree to abide by his/her decisions.

Furthermore, I/we agree to and will uphold the rules set forth by the St. Paul Park Heritage Days Festival Parade Director and his/her representatives, including but not limited to, parade units and the laws regarding consumption of alcohol by drivers, passengers, or unit participants during line up, on the parade unit, along the parade route or at the end of the parade.
